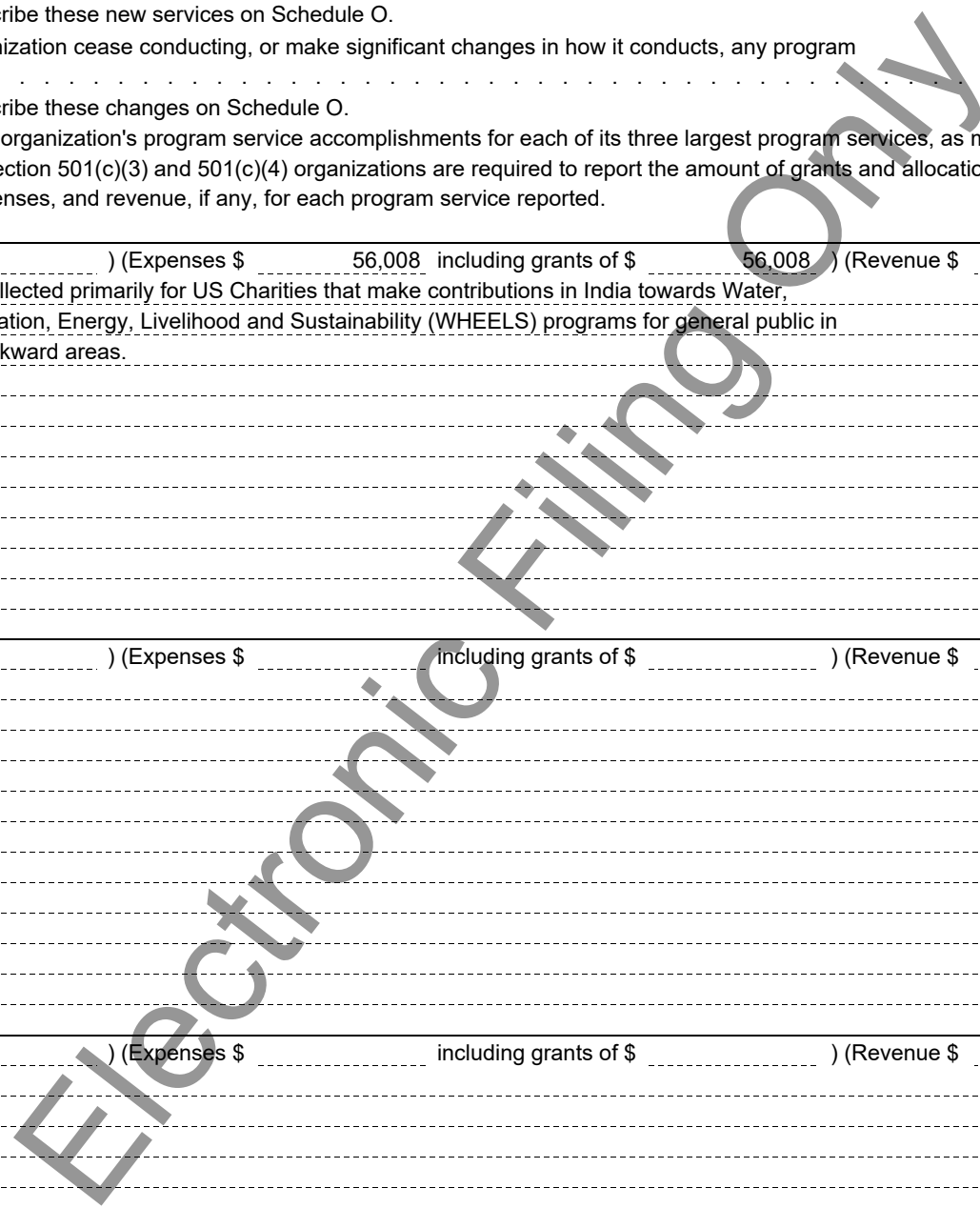

for reporting requirements including the filing of the tax return. After the tax is prepared

by an independent auditor and the return is reviewed by the WGF board member who approves and

signs it.
